# **Prohibited Items or Services**

### PROHIBITED SECTION

Users are strictly prohibited from posting ads, images, or content that fall under the following categories:

### 1. Prohibited Content

# 1.1. Pornography and Explicit Content:

 Any materials or images containing pornographic or erotic content, especially those involving individuals under the age of 15, violence, and/or animals.

# 1.2. Hate Speech and Discriminatory Content:

• Items, images, or symbols promoting hate speech, violence, or discrimination based on nationality, ethnicity, race, religion, or cultural differences.

### 2. Prohibited Goods

### 2.1. Alcohol and Tobacco:

- Unregulated alcoholic beverages (e.g., homemade or unbottled spirits without excise duty).
- Tobacco products and related items, including raw tobacco.

# 2.2. Food and Pharmaceutical Products:

- Expired or improperly stored food products, including those of animal origin.
- Prescription medications or drugs that can only be sold in licensed pharmacies.

### 2.3. Hazardous Substances:

- Dangerous chemicals in pure form that can threaten life, health, or the environment (e.g., sulfuric acid, controlled substances).
- Narcotics, psychotropic substances, and their analogs or precursors.

# 2.4. Weapons and Explosives:

• Weapons, firearms without permanent functional properties, gas-dispersing devices, explosives, and ammunition.

## 2.5. Human and Animal Products:

- Human or animal organs, tissues, cells, blood, and blood components.
- Ivory and products made from it.
- Endangered species (alive or dead) and their derivatives.
- Cats and dogs from unregistered breeders or facilities.
- Sale or trade of animals still dependent on their mother for nourishment and care.

### 2.6. Counterfeit and Fraudulent Products:

- Counterfeit products or services.
- Goods misleading customers regarding their true origin, quality, or characteristics.
- Sale of counterfeit coins and banknotes.

# 2.7. Illegal Software and Digital Products:

- Software and tools intended for illegal activities.
- Materials that infringe personal rights, including intellectual property.
- Intellectual and industrial property items sold without permission from the rightful owner.
- Software marked as "Not for Resale" (NFR), freeware, shareware, or abandoned software.
- Software designed to facilitate activities violating the law or public morality.
- Sale of product keys, programs, or protections without the inclusion of original software.

### 3. Prohibited Services

# 3.1. Illegal Activities:

- Fishing products or services restricted or banned under applicable laws.
- Reproduction or imitation of public documents, passports, or fraudulent health certificates.
- Instructions or website addresses that allow or facilitate illegal activities.

## 3.2. Digital and Online Accounts:

- Accounts from free websites, free email accounts, and instant messaging applications.
- Accounts created using free internet services or invitation-only platforms.
- Accounts tied to loyalty or affiliate programs.
- Accounts from digital content or gaming distribution platforms.

# 3.3. Personal Data and Communications:

- Personal data or lists of email addresses.
- Bulk email communication services, such as mass email processing.
- Services related to sending SMS to premium numbers (e.g., Premium SMS).

### 3.4. Fraudulent Financial Activities:

- Services and goods linked to participation in "pyramid schemes" or similar structures.
- Investment schemes and gambling services, including market access services.

## 3.5. Other Prohibited Services:

- Services related to writing or creating academic theses, essays, or similar reports.
- Ads for clairvoyance and fortune-telling.
- Prepaid phone services for pre-registered SIM cards.
- Job or collaboration offers requiring upfront payment or fees.

#### 4. Other Prohibitions

## 4.1. Undisclosed or Unclear Items:

Boxes, containers, and envelopes whose contents are not clearly disclosed.

#### 4.2 Postal and Courier Restrictions:

 Items and substances prohibited from shipment via postal or courier services according to local laws.

#### 5. Other:

5.1. Any other goods or services not explicitly mentioned but are prohibited under applicable laws or regulations.

## **CONDITIONAL SECTION**

Users may post ads, images, or content under the following conditions:

# 1. Animals and Living Organisms

# 1.1. Animals (except those listed as prohibited items):

• **Conditions**: The seller must declare and ensure safe and humane transport conditions (preferably personal collection) and comply with veterinary health requirements specific to the type of animal (e.g., passport, vaccinations, etc.).

# 1.2. Animals, plants, fungi, or microorganisms that may threaten native species or natural habitats:

• **Conditions**: The seller must provide and publish an official permit allowing the sale and management of these species from the relevant authority.

# 2. Digital Products and Content

# 2.1. Electronic Publications (e.g., books, monographs, poems, guides):

• **Conditions**: The seller must declare that they are the sole author of the publication or its publisher.

# 2.2. Licensed Software:

• **Conditions**: The seller must declare that the software does not violate licensing agreements.

# 2.3. Goods with Digital Elements, Digital Content, or Digital Services:

 Conditions: Business users must determine the need to provide information about the characteristics of goods with digital elements or digital content, based on their specific features.

## 3. Equipment and Tools

## 3.1. Equipment Manuals:

• **Conditions**: The seller guarantees that the manual is sold together with the corresponding equipment. If sold separately, the seller must declare that the manual is the original version.

## 3.2. Air Guns:

• **Conditions**: The seller must declare that the projectile/air pressure does not exceed the permitted limits in the respective country.

# 3.3. Weapons, Equipment, and Consumables for Security and Hunting:

Conditions: Users may only post ads for hunting and security weapons and their
consumables in the "Hunting" category. The ad author must declare that they have the
appropriate permits or documents. Before posting, the user must familiarize themselves
with the local and international laws of the country or countries where the ad will be visible.

## 3.4. Weapons, Equipment, and Consumables for Sport Shooting and Tactical Activities:

• Conditions: Ads for sporting weapons, equipment, and consumables may only be posted in the "Shooting & Tactical Activities" category and its sub-categories. The ad author must declare that the items are solely for sport shooting or tactical activities (e.g., Laser Tag, Gel Blaster, Airsoft, Nerf, Splatmaster Paintball, Archery Tag, Water Guns). The ad author must comply with relevant local and international laws.

# 3.5. Protective Vests, Military and Police Helmets, Face Shields, and Other Protective Gear:

• **Conditions**: The seller must declare that the items are not defense-related or dual-use products.

## 4. Refrigerants and Environmental Products

# 4.1. Refrigerants (e.g., Fluorinated Greenhouse Gases and Ozone-Depleting Substances):

 Conditions: The seller must declare that the refrigerant complies with local regulations and adhere to any other registration requirements (e.g., registration as a distributor of fluorinated gases).

## 5. Financial Products and Services

## 5.1. **Loans:**

Conditions: Loan ads may only be posted by entities registered as financial institutions. The
ad title and description must clearly specify the credit institution represented by the ad
author.

### 6. Entertainment and Collectibles

# 6.1. Tickets for Artistic, Entertainment, or Sports Events:

• **Conditions**: The seller must declare that the price or value of the ticket is equal to or less than its face value (printed on the ticket).

## 6.2. Ads for Coins and Banknotes with Collectible or Numismatic Value:

• Conditions: Ads for collectible coins and banknotes must refer to items that are no longer in circulation. The ads must include as much detail as possible (e.g., origin, year of issue, serial number, original photos, condition, distinctive features).

### 7. Erotic Devices and Items

# 7.1. Erotic Devices and Items (e.g., vibrators, sex dolls):

Conditions: Ads for erotic devices and items may only be posted in the "Sexual Care (Adults Only)" category. Ads in this category are only visible within the category and do not appear elsewhere on the site. Promotion of ads in this category is possible only within "TOP Local Category Page" and "TOP International Category Page" options. Promoted ads are not visible outside the "Sexual Care (Adults Only)" category.

**Important**: The ad author is solely responsible for the content of their ad. Before posting, the author must familiarize themselves with the local and international laws of the country or countries where the ad will be displayed.
